

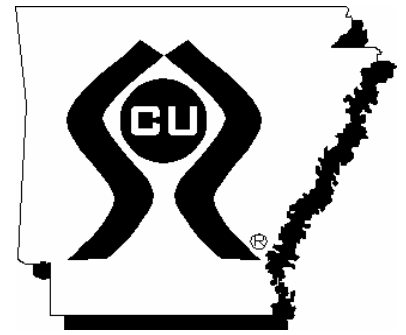

# 72nd Annual Report

## President's Report

In 2017 we ended the year with over 5 million in assets. We accepted 45 new members and now have a total membership of 957.

Competition from auto dealers and other financial institutions is continuing to limit our loan growth. Credit Card loans have decreased slightly from last year. At the end of 2017 43% of our membership had a Credit Union Visa Card.

We continue to fund a \$1,000 scholarship to be awarded annually to a graduating 4-H member for attendance at an institution of higher education in Arkansas.

We held our 17th Annual Silent Auction in September to raise money for Arkansas Children's Hospital.

We have received a 5 star rating from Bauer Financial for 52 consecutive quarters. This is the highest rating that a financial institution can receive.

We ended 2017 with positive income.

## Board of Director's Report

The Board of Directors met regularly each month to oversee the credit union's operations. To keep members informed about the credit union we published four quarterly newsletters. At the end of each quarter we analyzed the funds available to declare dividends. A dividend of .25% was declared for the four quarters of 2017.

Realizing that planning for the future is vital to the success of the credit union, we again developed a strategic plan for the year. The plan will be updated on an annual basis.

We ran numerous loan specials during the year and held a membership drive the first part of the year.

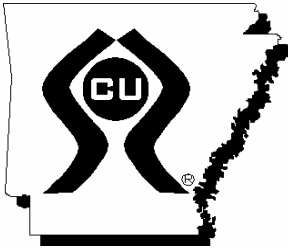
## Supervisory Committee
